



APPLICATION FOR SUMMARY REVIEW PROCEDURE

This application form is used by the County of Rio Arriba pursuant to Appendix P, Section F, Subsection 1, and Appendix Q of the County's Land Subdivision Regulations Ordinance.

The purpose of this application form is to:

- 1) Ensure compliance with the above-stated regulation, and
- 2) Provide applicants with a flexible format for presenting the most relevant information regarding the appropriateness of applying the Summary Review Procedure to the proposed division of land.

NOTE that the Board of County Commissioner's review of this application form is PRELIMINARY, and ONLY allows the Summary Review Procedure to be applied by the Planning and Zoning Department to the proposed division of land. FINAL approval of the applicant's proposed division of land will proceed in accordance with the County's Land Subdivision Regulations Ordinance. (See attached flow chart)
