**CALLING FOR A LA CLINICA DEL PUEBLO DE RIO ARRIBA
EMS/AMBULANCE SPECIAL HOSPITAL DISTRICT (THE "DISTRICT")
SPECIAL ALL-MAIL BALLOT ELECTION TO BE HELD IN THE
DISTRICT, COUNTY OF RIO ARRIBA, STATE OF NEW MEXICO ON
JULY 18, 2023, FOR THE PURPOSE OF VOTING ON IMPOSITION OF
AN OPERATIONAL AD VALOREM TAX MILL LEVY IN THE AMOUNT
OF 3.50 MILLS**

WHEREAS, the Board of Trustees (the "Board") of the La Clinica Del Pueblo de Rio Arriba EMS/Ambulance Special Hospital District (the "District"), in the County of Rio Arriba, State of New Mexico, has determined that a special all-mail ballot election (the "Election") shall be held on July 18, 2023, to vote on imposition of an operational ad valorem tax mill levy question, and that a Resolution and Proclamation of the Election shall be issued by the Board, in accordance with Section 1-24-2, NMSA 1978 as amended and supplemented;

WHEREAS, in accordance with Section 1-24-2, NMSA 1978, a special District Election shall be held, and a Resolution and Proclamation of the Election shall be issued by the Board;

WHEREAS, the Board has determined upon its own initiative to submit to a vote the question of the imposition of an ad valorem tax mill levy in the amount and for the purposes hereinafter specified, as permitted by Section 4-48A-16, NMSA 1978, at the Election; and

WHEREAS, the ad valorem tax question herein submitted has not been defeated at an election held within a period of two years from the date of ad valorem tax election hereinafter set forth; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE LA CLINICA DEL PUEBLO DE RIO ARRIBA EMS/AMBULANCE SPECIAL HOSPITAL DISTRICT, COUNTY OF RIO ARRIBA, STATE OF NEW MEXICO THAT THE FOLLOWING RESOLUTION AND PROCLAMATION BE AND IT HEREBY IS ISSUED:

RESOLUTION AND PROCLAMATION

Section 1. A special all-mail ballot election (the "Election") for the La Clinica Del Pueblo de Rio Arriba EMS/Ambulance Special Hospital District, County of Rio Arriba, New Mexico (the "District") shall be held on July 18, 2023.

Section 2. There shall be submitted to all qualified registered electors of the District at the Election to be held on July 18, 2023, the following question:



Section 3. The election shall be conducted in accordance with the Special Election Act, Sections 1-24-1 through 1-24-6, NMSA 1978, and the Absent Voter Act, Sections 1-6-1 through 1-6-25, NMSA 1978, and where needed, other sections of the Election Code (Chapter 1 of NMSA 1978). In accordance with Section 1-24-3, NMSA 1978, ballots will be mailed to each qualified, registered elector of the District beginning no earlier than June 21, 2023, the twenty-seventh day before the election, along with a notice that there will be no polling place on election day. It is not necessary to apply for a ballot. Ballots must be received by the election judges no later than 7:00 p.m. on the day of election, and ballots shall be counted at the Conference Room at the Rio Arriba Clerk’s Office, 10 State Road 531, Tierra Amarilla, New Mexico, 87575.

Section 4. The County Clerk of Rio Arriba County, New Mexico is required by law to close the registration books at the end of the day on July 14, 2023, and a person will be allowed to vote only if he or she is an elector of the District and currently registered to vote in the District at that time. Any qualified elector of the District who is not now registered and who wishes to vote at the election should register during regular office hours at the office of the County Clerk of Rio Arriba County, 1122 Industrial Park Road, Espanola, New Mexico 87532 and Rio Arriba Clerk’s Office, 10 State Road 531, Tierra Amarilla, New Mexico, 87575 or with any registration agent at a designated agency as provided in Sections 1-4-48 and 1-4-49, NMSA 1978, prior to the end of the day on July 14, 2023.
